NOTICE IS GIVEN that a contested case and formal proceedings pursuant to Idaho Code § 67-5240, Idaho Code § 47-328(1), and IDAPA 04.11.01.104 are hereby initiated by the Idaho Oil and Gas Conservation Commission ("Commission") for the following purpose:

TO DETERMINE WHETHER THE INTEGRATION ORDER IN DOCKET NO. CC-2016-OGR-01-001 APPLIES TO THE PERMITTED PROPOSED BARLOW #2-14 WELL.

The Commission initiated this contested case at a December 9, 2020 special meeting because it believed a question may remain as to whether the integration order in Docket No. CC-2016-OGR-01-001 (Section 14, Township 8 North, Range 5 West, Boise Meridian, Payette County, Idaho) applies to the Barlow #2-14. Some mineral interest owners have raised concerns over the position of Snake River that this prior integration order applies to the Barlow #2-14. The Commission believes that initiating a contested case as to the application of the integration order in Docket No. 2016-CC-OGR-01-001 is the procedural mechanism to determine the applicability of the prior integration order to the Barlow #2-14, under the terms of Idaho statutes, the Commission's rules, and the prior integration order itself.

The Idaho Oil and Gas Conservation Act expressly allows the Commission to hear questions about the applicability of an agency-issued order. Idaho Code § 47-328(1) ("The commission shall have authority to hear . . . any other matter the commission decides should be

heard by the commission. The commission may act upon its own motion."). By initiating this contested case, the Commission can hear the question of whether the integration order in Docket CC-2016-OGR-01-001 applies to the Barlow #2-14, and the Commission may allow participation by interested parties in the case. That participation could include persons such as Snake River, mineral interest owners in Section 14, Township 8 North, Range 5 West, Boise Meridian, Payette County, Idaho subject to the integration order in Docket No. CC-2016-OGR-01-001, and other persons who claim a direct and substantial interest in the proceeding. Additional information about scheduling and participation in the case will be determined by the hearing officer and published in future notices.

Persons who are interested in this matter should respond with their contact information to receive additional notices and communication. That response should include your name, address, and e-mail (if applicable). Responses should be addressed as follows:

For purposes of this contested case, pursuant to Idaho Code § 67-5242 and IDAPA 04.11.01.410, the Commission HEREBY DELEGATES to its Secretary, Mick Thomas, the authority to appoint a hearing officer to oversee the contested case.

The Commission instructs Mr. Thomas to appoint a hearing officer to handle all procedural and pre-hearing matters, including any requests for discovery. IDAPA 04.11.01.413. The hearing officer shall also serve as the presiding officer at hearing. *Id.* After the hearing, the hearing officer shall submit a recommended order to the Commission in accordance with IDAPA 04.11.01.720. The

Commission will decide to adopt, reject, or amend the hearing officer's recommendation. The Commission will make the final decision in this matter.

This proceeding is governed by the Oil and Gas Conservation Act (Chapter 3, title 47, Idaho Code); the Idaho Administrative Procedure Act (Chapter 52, title 67, Idaho Code); Idaho Rules of Administrative Procedure of the Attorney General (IDAPA 04.11.01), to the extent that the Rules of Administrative Procedure are not superseded by Oil and Gas Conservation Act; and the Rules Governing Conservation of Oil and Natural Gas in the State of Idaho (IDAPA 20.07.02). A copy of the Rules of Administrative Procedure is available at the Idaho Department of Lands office located at 300 N. 6th Street, Suite 103, Boise, Idaho, and at the Office of Administrative Rules Coordinator's website, accessible at http://adminrules.idaho.gov.
