NOTICE OF HEARING**

NOTICE IS HEREBY GIVEN that the Application of Snake River Oil and Gas, LLC for Integration of Unleased Mineral Owners in the above-docketed matter will come before the Administrator for hearing. Pursuant to instruction from the Administrator:

1. The May 13, 2021 regularly scheduled date for an evidentiary hearing is vacated.
2. The Administrator sets a May 20, 2021 hearing on the specific issue of what factors the Administrator will consider when he determines whether the terms and conditions of an integration order are “just and reasonable.”

3. The Applicant, the Department, and any uncommitted owner in the above-captioned spacing unit may file briefs and any supporting affidavits on this topic.

4. Opening Briefs must be filed with the Department by 5:00 p.m. (MT) on April 28, 2021.

5. Response briefs must be filed with the Department by 5:00 p.m. (MT) on May 12, 2021.

6. Reply briefs must be filed with the Department by 5:00 p.m. (MT) on May 17, 2021.

4. Written public comments must be filed with the Department by 5:00 p.m. (MT) on May 12, 2021.

5. The hearing will be held at 1:00 p.m. at Fruitland City Hall, 200 S. Whitley Dr., Fruitland, Idaho, with a Zoom teleconference option also available for remote attendance. Further hearing will be as scheduled by the Administrator.

This proceeding is governed by the Oil and Gas Conservation Act (Chapter 3, title 47, Idaho Code); the Idaho Administrative Procedure Act (Chapter 52, title 67, Idaho Code); Idaho Rules of Administrative Procedure of the Attorney General (IDAPA 04.11.01), to the extent that the Rules of Administrative Procedure are not superseded by Oil and Gas Conservation Act; and the Rules Governing Conservation of Oil and Natural Gas in the State of Idaho (IDAPA 20.07.02). A copy of the Rules of Administrative Procedure is available at the Idaho Department of Lands office located at 300 N. 6th Street, Suite 103, Boise, Idaho, and at the Office of Administrative Rules Coordinator's website, accessible at <http://adminrules.idaho.gov>.

Pursuant to Idaho Code § 67-5242(3)(c), the Administrator will also provide an opportunity for public testimony at the May 20, 2021 hearing. Any person planning to testify will be treated as a public witness, with their rights and status in this matter as defined by IDAPA 04.11.01.355. The hearing officer may set time limits for public testimony if necessary. In addition, members of the public may file written comments with the Idaho Department of Lands as set forth above. Filing written comments is not required for a person to testify at the hearing as a public witness.

The hearing location meets the accessibility requirements of the Americans with Disabilities Act ("ADA"), in accordance with IDAPA 04.11.01.551. If a person requires assistance of the kind the agency is required to provide under the ADA in order to participate in or understand the hearing, the agency will supply the assistance upon request. 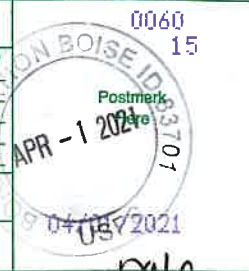

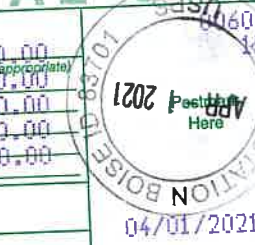

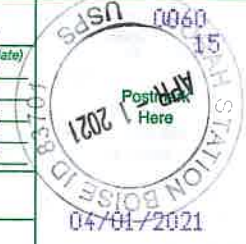
