**NOTICE OF INITIATION OF CONTESTED CASE**

The Idaho Oil and Gas Conservation Commission has initiated a contested case and formal proceedings pursuant to Idaho Code § 87-5240, Idaho Code § 47-328(1), and IDAPA 04.11.01.104 for the following purpose:

TO DETERMINE WHETHER THE INTEGRATION ORDER IN DOCKET NO. CC-2016-OGR-01-001 APPLIES TO THE PERMITTED PROPOSED BARLOW #2-14 WELL.

The Commission initiated this contested case at its December 9, 2020 special meeting because it believed a question may remain as to whether the integration order in Docket No. CC-2016-OGR-01-001 (Section 14, Township 8 N, Range 5 W, Boise Meridian, Payette County, ID) applies to the Barlow #2-14.
