**ORDER VACATING HEARING &
DISMISSAL OF APPLICATION**

Snake River Oil and Gas, LLC (“Snake River”) filed a Notice of Withdrawal with the Oil and Gas Division Administrator of the Idaho Department of Lands on August 25, 2022, in the above-captioned matter.

Pursuant to IDAPA 04.11.01.305, “[a] party desiring to withdraw a pleading must file a notice of withdrawal of the pleading and serve all parties with a copy.” The presiding officer may order that the notice of withdrawal is effective sooner than fourteen (14) days after filing. IDAPA 04.11.01.305. The Administrator hereby orders that the notice of withdrawal is effective as of August 30, 2022, and this matter will terminate without prejudice to Snake River’s ability to submit a new application. Given the withdrawal, no rulings will be issued on any currently pending motions.

For the reasons above, IT IS HEREBY ORDERED that a dismissal is effective August 30, 2022, and the September 8, 2022 hearing be vacated.


