To all uncommitted mineral interest owners in the SE ¼ of Section 15, the E ½ of the SW ¼ of Section 15, and the NE ¼ of Section 22, Township 8 North, Range 5 West, Boise Meridian, Payette County, Idaho:

On May 22, 2025, pursuant to Idaho Code § 47-317 and § 47-328 Snake River Oil and Gas, LLC filed an application with the Idaho Department of Lands for an order establishing a spacing unit described as the SE ¼ of Section 15, the E ½ of the SW ¼ of Section 15, and the NE ¼ of Section 22, Township 8 North, Range 5 West, Boise Meridian, Payette County, Idaho. All uncommitted interest owners in the proposed spacing unit will have an opportunity to respond to the application. Unless rescheduled to a later date by the Department or the Idaho Office of Administrative Hearings, the hearing on the application will be held according to the Department's regular hearing schedule on July 10, 2025, or at such later date as is set by the Department or the Idaho Office of Administrative Hearings. Pursuant to Idaho Code §47-317 and §47-328, Applicant Snake River Oil and Gas, LLC ("Applicant") submits this application for an order establishing a gas spacing unit consisting of the SE ¼ of Section 15, the E ½ of the SW ¼ of Section 15, and the NE ¼ of Section 22, Township 8 North, Range 5 West, Payette County, Idaho, in Township 8 North, Range 5 West, Payette County, Idaho. This application is based on the following:

1. Idaho Code §47-317(1): <u>To prevent or assist in preventing the waste of oil and gas, to avoid drilling unnecessary wells or to protect correlative rights, the department may, on its own motion or on the application of an interested person, and after notice and opportunity for hearing, issue an order establishing spacing units on a statewide basis, or for defined areas within the state, or for oil and gas wells drilled to varying depths.</u>

Applicant proposes a spacing unit consisting of the defined area of the SE ¼ of Section 15, the E ½ of the SW ¼ of Section 15, and the NE ¼ of Section 22, Township 8 North, Range 5 West, Payette County, Idaho in Township 8 North, Range 5 West, as illustrated on the plat map attached hereto as **Exhibit A**. The uncommitted mineral owners in the proposed unit area are set forth in the exhibit attached hereto as **Exhibit B**. The tract numbers listed on Exhibit B correlate to the same numbers included on the sub-exhibits to Exhibit A. Because of the number of tracts included

in the proposed unit, Exhibit A includes sub-exhibits A-1 through A-6, illustrating the tracts in the described portions of the proposed unit area. Tracts committed by lease are reflected on Exhibits A-1 through A-6 in yellow, and uncommitted tracts are in white.¹

As set forth in the Declaration of Richard Brown attached hereto as **Exhibit C**, Applicant is an "interested person" for purposes of Idaho Code § 47-317(1) by virtue of currently holding over 50% of the net mineral acres in proposed spacing unit area by lease. Applicant is an "owner" as defined by Idaho Code § 47-310(27) as to each tract leased by it in the proposed spacing unit area, as by virtue of each lease Applicant is "the person who has the right to drill into and produce from a pool and to appropriate the oil and gas that he produces therefrom, either for himself or for himself and others."

As set forth in the Declaration of David Smith and the exhibits to it, attached hereto as **Exhibit D** and discussed below, Applicant submits that the proposed spacing unit configuration will prevent waste, avoid the drilling of unnecessary wells and protect correlative rights.

2. Idaho Code § 47-317(2): An order establishing spacing units shall specify the location, size, and shape of the unit, which, in the opinion of the department, shall result in the efficient and economical development of the pool as a whole. These units established by the department shall be geographic. The geographic boundary of the unit shall be described in accordance with the public land survey system. The department shall issue an order establishing a spacing unit or units to determine the area that can be efficiently and economically drained by one (1) well for the orderly development of the pool.

As set forth in Exhibit D, Applicant submits that the proposed spacing unit will result in the efficient and economical development of the pool as a whole. The proposed spacing unit is described in accordance with the public land survey system, and within that requirement describes the area that can be efficiently and economically drained by one well for the orderly development of the pool.

A standard spacing unit consisting of either all of Section 15 or all of Section 22 would not accomplish the orderly development of the pool or describe the area that can be economically or efficiently drained by one well, as large areas of either unit would be outside the drainage area of an anticipated well targeting Sands A and B. Compensation to owners of those areas would injure the correlative rights of owners of the minerals within the drainage area of the well. "Correlative rights" are defined in the Act to mean "the opportunity of each owner in a pool to produce his just and equitable share of oil and gas in a pool without waste." Idaho Code § 47-310(8). Additionally, development according to standard spacing would result in inefficient drainage, could diminish

Farmer's Ditch occupies a right of way, and ownership of adjacent tracts extends to the center line of the ditch, subject to the ditch right of way. Committed adjacent tracts are thus highlighted in yellow to the center line of the ditch, and the ditch is not identified as a separate tract. Subdivision streets are dedicated to Highway District No. 1, and by operation of law under Idaho Code §50-1312, acceptance of the plat "is equivalent to a deed in fee simple of such portion of the premises platted as is on such plat set apart for public streets[.]"

the quantity of hydrocarbons ultimately produced from Sands A and B, and require unnecessary additional wells, causing waste. Idaho Code § 47-310(36)(a).

The proposed unit area is described by geographic subdivision as required by Idaho Code § 47-317(2). The proposed unit area is not required to exactly describe the outlines of the sand to be tested and produced. Idaho Courts in other states have erred on the side of the inclusion of questionable acreage when confronted with claims of barren acreage within a spacing unit. *See Amoco Production Co. v. Ware*, 602 S.W.2d 620 (Ark. 1981).

3. Idaho Code § 47-328(3)(b): For applications involving an order regarding establishment or amendment of a spacing unit, . . . the applicant shall send a copy of the application and supporting documents to all known and located uncommitted mineral interest owners, all working interest owners within the proposed spacing unit, and the respective city or county where the proposed unit is located. The mailing shall be sent by certified mail within seven (7) days of filing the application and include notice of the hearing date on which the administrator will consider the application. For any uncommitted owners and working interest owners who cannot be located, an applicant shall publish notice of any application for an order, notice of hearing and response deadline once in a newspaper of general circulation in the county in which the affected property is located and request the department publish notice on its website within seven (7) days of filing of the application.

Within seven days of the filing of this Application, Applicant will mail a copy of this application and its supporting exhibits, along with a notice of the hearing date on which the Administrator will hear the application according to the Department's regular hearing schedule, or such other hearing date as is ordered, to all uncommitted mineral interest owners in the proposed spacing unit area, as listed on Exhibit B, as well as to uncommitted mineral interest owners in properties contiguous with the proposed spacing unit area.² Applicant will separately file copies of mailing receipts with the Department following the mailing.

Applicant has identified some unlocatable mineral interest owners as identified on Exhibit B. Notice to them, their heirs and successors, and all uncommitted mineral interest owners, of the Application, including notice of the regularly scheduled hearing date and notifying uncommitted mineral owners of their opportunity to obtain a copy of the Application materials and file any response to it with the Department, will be published in a paper of general circulation. Applicant will file proof of publication when publication of the notice is complete. We request that the Department publish notice of the application on its website.

The next regularly scheduled administrative hearing date listed on the Department's website is July 10, 2025.

^{§ 328(3)(}b) does not require notice to mineral owners outside the proposed unit area, but in an exercise of caution Applicant is noticing those uncommitted owners of tracts contiguous to the proposed unit area not already receiving notice by virtue of owning property inside the proposed unit area.




Exhibit A-1

Rivercrest Subdivision



N1/2E1/2SE1/4 Section 15, Township 8 North, Range 5 West




Exhibit A-4
S1/2E1/2SW1/4 Section 15, Township 8 North, Range 5 West




Exhibit A-5
Section 22, Township 8 North, Range 5 West



DECLARATION OF DAVID M. SMITH

I, David M. Smith, declare:

1. I have over 40 years' experience in domestic and international exploration, development and acquisitions/divestitures of oil and gas properties. I have been involved in Idaho oil and gas exploration since 2012. I worked in exploration at Paramount Petroleum and Torch Energy Advisors, Inc., and served as the Exploration Manager for Bellwether Exploration Company. I served as the Vice President of Geosciences for Alta Mesa Holdings. I earned a Bachelor of Science in Geology from Virginia Tech. I am a working interest partner in and consult for Snake River Oil and Gas, LLC in Idaho. Included in my responsibilities are interpreting data from 2-D and 3-D seismic projects, identifying and evaluating likely pools based on interpretation

of seismic and geologic data, selecting drilling targets based on such interpretation and evaluation, and interpreting the geophysical logs acquired during drilling operations.

- 2. I designed and supervised the acquisition of a 3-dimensional (3-D) seismic survey with specific parameters to explore for oil and gas reservoirs, appropriate to the challenges of this sedimentary basin. The sediments are often complexly faulted. There are often numerous basalt flows, dikes and sills present in the subsurface. These conditions complicate geologic interpretations from geophysical data.
- 3. I interpreted these seismic data from a project which covered several sections in Township 8 North, Range 5 West, Payette County, Idaho, including the SE ¼ of Section 15, the E½ of the SW ¼ of Section 15, and the NE ¼ of Section 22 ("the subject spacing unit").
- 4. My exploration approach in this basin is to rigorously interpret 3-D seismic data while incorporating and integrating subsurface knowledge gained from wells which we have previously drilled in the basin. The interpretation of these data is informed and guided by field work in the basin studying the sediments in outcrop and extensive review of previous geologists published work in the basin.
- 5. The time information contained in the 3-D seismic data can be used to estimate the depth of specific horizons of interest extrapolating away from well control into undrilled areas.
- 6. Immediately after drilling a well, we record (or "log") multiple geophysical parameters of the rocks exposed in the open wellbore by lowering multiple instruments to the bottom of the hole and slowly withdrawing them back to the surface as we measure and record the responses from the rocks over every foot of section. These records are called "Open Hole Logs" or "OHL's".

- 7. One of the instruments in the OHL suite, the Sonic log, measures the transit time of a sound pulse through each rock type encountered at the varying depths in the wellbore. These measurements can be analyzed and compiled to produce a time-depth chart which estimates the time that a sound pulse from the surface would take to reach a known depth in that particular wellbore.
- 8. This time depth relationship can be utilized with the time information contained in the 3-D seismic and used to identify and "tie" specific reflections which are created by specific rock types or formations encountered in the wellbore.
- 9. The specific reflection or "horizon" of interest can then be mapped in the 3-D seismic volume laterally away from the wellbore into unexplored areas, and informed interpretations can then be made as to that horizon's depth, and presence or absence at other locations within the 3-D survey.
- 10. Additionally, I study the seismic responses produced by the different rock types (lithologies) encountered and the seismic responses from sands with different thicknesses and fluid types (typically gas-saturated versus water-saturated sands of varying thicknesses). In certain settings, a gas-saturated sand can produce an anomalous seismic response (Amplitude Anomaly or AA) which differs markedly from that produced by a water-saturated sand. The anomalous response is produced because the presence of gas in a sand's pore spaces lowers its density and the transit time velocity of a sonic pulse through the gas bearing portion of a sand, relative to the density and transit time of a water bearing sand. Mapping the area of the anomalous response can give a reasonable approximation of the area of the presumed gas reservoir.

- 11. Exhibit G1 addresses the OHL and seismic response of the Fallon #1-10 well, a known Sand B gas productive well just to the north of the proposed new spacing unit.
- 12. G1.1 shows the measured depth OHL of the Fallon #1-10 well over the Sand B interval. The Gamma Ray (GR) log indicates that Sand B is present from 3770' to 3940' measured depth (yellow shaded area). The Induction Log (IND) indicates that the upper part of Sand B is gas bearing from 3770' to 3880' (red shaded area), and the lower part from 3880' to 3940' is water bearing. Additional OHL's, specifically the sonic log and the density neutron log confirm that the upper part of Sand B above the indicated Gas Water Contact (GWC) is gas bearing due to the lower density and slower transit times recorded in that interval.
- 13. Exhibit G1.2 is an extracted seismic line from the 3-D volume, oriented west to east and passing through the Fallon #1-10 well. The time-scaled GR log (gold) and Induction (red) curves are displayed on the seismic line. The top of Sand B is indicated on the seismic line by "Sd B" and the Gas Water Contact by "G/W". The low-density, low-velocity gas bearing region of Sand B produces an anomalous seismic response, or Amplitude Anomaly (AA), which is shaded red on the seismic line.
- 14. The east termination of the AA is the stratigraphic termination (ST) of Sand B, indicated as "ST" on the exhibit. This stratigraphic termination is a very mappable NW-SE trending sub-regional event. Supporting this interpretation is the fact that Sand B is not found in the several wells to the east.
- 15. The west termination of the AA is indicated as GWC, or the "Gas Water Contact" in Sand B. While reflections above and below this event exhibit regional structural dip to the west

(left), this GWC event is flat lying, confirming that we are imaging the GWC with the 3-D seismic. To the west of this point Sand B is structurally lower and only water bearing.

- 16. The boundaries of the existing Fallon #1-10 and Fallon #1-11 units are shown as vertical dashed lines.
- 17. Exhibit G1.3 is an Isochron Map of the Gross Gas Bearing Interval of Sand B. It is created by subtracting the time values of the top Sand B horizon (red) from the base Sand B Gas interval horizon (blue) as mapped throughout the 3-D seismic volume.
- 18. G1.4 is the scale for the Isochron Map, expressed in two-way time seconds. Visually, the thicker intervals are grading from light blue through yellow, orange, and red.
- 19. Also of note on G1.2, the AA associated with gas productive Sand D in the Fallon #1-11 well is visible on the right edge of the seismic line, and the edge of the Fallon #1-11 Unit.
- 20. This G1 exhibit is offered as an example of how we can determine the presence of gas bearing sands and map their distribution spatially. The proposed boundaries of the new spacing unit are proposed utilizing these same technologies and methodologies.
- 21. Exhibit G2 addresses the OHL and seismic response of the Barlow #2-14 well, another Sand B gas productive well, and shows its relation to the proposed new spacing unit.
- 22. Exhibit G2.1 is the Open Hole Log (OHL), specifically the Gamma Ray and Induction logs, for the Barlow #2-14 well over the Sand B interval. Note the top and base indicated, the Gross interval is approximately 30 feet thick (3908-3938'), but there is only perhaps 10 to 13 feet of gas bearing sand present. This highlights a weakness of our current ability to use the seismic tool, that is the seismic resolution of thin sands. We can map the top and base of the Gross gas

bearing interval in many conditions but are often unable to resolve small but important details of net sand thickness. This well, while productive, may not be economic.

- 23. Exhibit G2.2 shows an extracted Southwest to Northeast 3-D seismic line across the proposed new unit and through the Barlow #2-14 well. The time-scaled Gamma Ray and Induction log curves are displayed and the top of Sand B indicated as "SD B".
- 24. Note that the Gross gas bearing zone is shaded red, and the stratigraphic termination of Sand B (ST) is indicated on the northeast (right) side of the figure.
- 25. The AA shaded red representing the gas bearing zone of Sand B can be seen to increase in time, and presumably thickness, to the southwest into the southern area of the proposed new unit. The proposed new unit boundaries are indicated by the black vertical dashed lines.
- 26. The western termination of the AA is indicated on the figure by "GWC", where the red horizon mapping the top of Sand B intersects with the blue horizon mapping the base of the gas bearing interval. Note that the "GWC" event is flat lying, while the reflections above and below the event show southwest dip, this condition supports the thesis that we are imaging a flat lying gas water contact and able to reasonably map the western edge of the Sand B gas pool.
- 27. Exhibit G2.3 is the Sand B Gross Gas Bearing Zone Isochron Map. Note that in the proposed new unit area the gross isochron map shows values in the 20 to 40+ milliseconds range, indicating that the Sand B gas bearing zone should be thicker to the southwest of the Barlow #2-14 well.
 - 28. Exhibit G2.4 is the scale for the Isochron map in two-way time seconds.
- 29. Exhibit G3.1 displays a north-south oriented 3-D seismic line through the area of the proposed new spacing unit and new unit well location.

- 30. The expected top of Sand B is indicated on the figure by "Sd B", the presumed area of gas bearing Sand B is the red shaded area highlighting the Amplitude Anomaly.
 - 31. The proposed new spacing unit boundaries are indicated by vertical dashed lines.
- 32. Note that most of the reflections on the 3-D seismic line are dipping to the south/southwest, other than the flat-lying reflection from the presumed gas water contact (indicated as GWC on the figure).
- 33. The location of the new proposed unit well would be south of the turquoise fault shown on G3.1 and G3.2.
- 34. Exhibit G3.2 is the same Sand B Gross Gas Bearing Zone Isochron Map showing the location of the seismic line and proposed unit outline.
 - 35. Exhibit G4 addresses the northern part of the proposed new spacing unit.
- 36. Exhibit G4.1 is the previously shown OHL from the Barlow #2-14 well, a known Sand B productive well, but with thin sands.
- 37. Exhibit G4.2 is a west to east oriented 3-D seismic line traversing the northern part of the proposed unit, the new unit well location and the Barlow #2-14 well.
- 38. The time scaled GR/Ind log curves are displayed on the seismic line and the top of Sand B is indicated (Sd B) at the Barlow #2-14 well location. Note the stratigraphic termination (ST) of the Sand B event to the east as the sand "pinches out" and is no longer present.
- 39. The Amplitude Anomaly (AA) representing the gas bearing portion of Sand B is highlighted red on the seismic line. Note that the time separation of the red and blue lines increases to the west. The red and blue horizons represent the top and base respectively of the gas bearing

portion of Sand B, therefore the gross thickness of Sand B gas bearing zone is inferred to increase to the west in the area of the proposed new spacing unit.

- 40. Note also that the reflections above and below the Sand B AA are west dipping, with the exception of the reflection labelled "GWC" which is interpreted to be the Gas Water contact (GWC) in Sand B in the new spacing unit.
- 41. The boundaries of the proposed new spacing unit are indicated as vertical black dashes on Exhibit G4.2.
- 42. Exhibit G4.3 is the previously shown Sand B Isochron Map with the location of the west to east 3-D seismic line G4.2 indicated in bold red on the map. Note that the proposed 400 acre geographic spacing unit efficiently covers the presumed gas bearing areas of Sand B, particularly the inferred thickest areas. Experience with the Barlow #2-14 well and its thin sands demonstrates that drilling in the "medium to dark blue" "thin" isochron areas may result in finding thin, uneconomic sands in the Sand B interval. As demonstrated by the local wells and 3-D seismic data, the "light blue to yellow-orange-red" "thicker" areas of the Isochron map are where the economically and efficiently producible gas/condensate reserves are to be found.
- 43. It is presently unknown whether the many small faults in this area would be sealing or non-sealing in the areas of "thick" sand B presence. The apparent widespread occurrence of observable "flat-spots" imaging a gas water contact around the northwest, west and southwest margins of the Sand B pool at approximately the same seismic time strongly argues in favor of the small faults being non-sealing, and capable of gas being produced across them.
- 44. The proposed well in the new unit would be an exploratory test primarily targeting Sands A and B. Sand A is a thin sand found productive (by log) in the Fallon #1-10 well, just

above Sand B. It is stratigraphically close in depth to Sand B and appears to have the same depositional pattern as Sand B, where it is mappable as a distinct event. In some cases, it may be so near to Sand B that it is imaged along with Sand B and not resolvable as a distinct event.

- 45. There is much to be learned about the geology of this basin, and our intention would be to drill some distance below the two primary objective sands and see the deeper section. Our intention would be to unitize these lands to all depths.
- 46. I declare under penalty of perjury under the laws of the State of Idaho that the foregoing is true and correct to the best of my knowledge.
