- Workplace safety
- Infrastructure degradation

The mineral rights were already sold to the house we purchased. We were never advised of any risks. From talking to people in the area, I do not believe any of the above risks were discussed with the property owners when permission for mineral, gas and oil rights were requested.

The state of Idaho should protect its citizens. Forbidding this type of drilling under residential or commercial land is a matter of common sense.

Furthermore, a 100% majority of signatures is not required under current law. Therefore, even if a homeowner does not want to sell their mineral and gas rights, they can be forced to sell, if enough other neighbors decide to. This is wrong as well.

This drilling should not be allowed.
