I, Wade Moore III, declare as follows:


1. I am the senior landman for Applicant AM Idaho, LLC.
2. I am responsible for reviewing the title for the three quarter sections, located in Sections 9, 15 and 16, for which additional notice has been required by the Administrator in his November 21, 2019 “Order Granting Petition to Intervene, Bifurcating Hearing, and Requiring Additional Notice” (“the Order”). I am generally familiar with land and ownership characteristics of the area, based on my work reviewing title for the original application for a unit and integration order covering the area, filed in 2016.
3. The ordered task involves reviewing title for approximately 200 tracts to determine whether uncommitted mineral ownership has changed since the original application was filed in 2016. Since the filing of an application for an order covering the affected area, at least one of the larger tracts has been subdivided into neighborhood lots, increasing the number of tracts to review.
4. Title review involves, at a minimum, retrieving county tax roll records for all uncommitted tracts in the affected area, comparing it to the mineral and surface ownership lists from when the application was filed, and reviewing all instruments of conveyance in each instance where there appears to have been a change of ownership in order to determine whether mineral ownership was conveyed or reserved.

5. With the large volume of tracts to review in order to update the list of mineral ownership for the affected area, and the intervention of the Thanksgiving holiday weekend, completion of the task required in the Order is difficult to impossible with the resources available to me. I do not currently have available to me additional land personnel to assist with the task.

6. Based on my experience, the information and resources available to me, and my other outstanding work requirements, I estimate it will take me until Friday, December 13, 2019 to complete the required review and prepare the necessary mailing. I estimate I will be able to deliver the required notice to the U.S. Postal Service for mailing by the end of day on December 13.

I certify and declare under penalty of perjury pursuant to the laws of the State of Idaho that the foregoing is true and correct.
