Letter about gas well in Fruitland, as requested by Julie Fugate.

June 4, 2020

To Whom It May Concern,

We are writing this letter in regard to the Barlow Gas Well site below our property near the Payette River in Fruitland, Idaho. Our initial meeting with Alta Mesa to discuss the well installation assured us that the well head site would not be on our property and that the process would be quick and barely noticeable. None of those assurances came to pass. We assumed that the health and safety of Idaho's citizens as spelled out in Idaho's constitution would be priority number one, and that the State and County would have our best interests at heart. But that has not always been the case.

After numerous town hall meetings we have all become aware of the flaws in the gas well drilling along the river corridor. Our water quality was not tested pre and post drilling, why not? Will global warming cause future flooding at the site? What are the risks of drilling under the river? How secure is the well head itself? Pipelines were installed close to homes whether they signed on or not. How will property values be affected? Lack of honest communication by the gas companies involved, the bankruptcies, and lawsuits have caused resentment, anxiety, and lack of trust among Payette County residents.

The State of Idaho needs to re-evaluate how the entire gas well industry moves forward if at all. Its citizens deserve better than the haphazard process that has unfolded.
