We own a house in Northview Ranch. We are opposed to this new spacing unit and all other spacing units. We are opposed to drilling close to neighborhoods.

And here we go again; another hearing for a spacing unit. As homeowners and also owners of our mineral rights, we feel like we are being subjected to a shell game. Just keep changing the size of the spacing units and resubmitting. Just keep changing the name of the company and a few of the owners. I feel like the intent is to wear us out so we will give up and let them do what they want. Yeah, well, they can all guess again. We will not go away and we will not stop fighting for our health, our property rights, and our beautiful state.

The last spacing hearing, I was at Fruitland City Hall. Mick Thomas, after the meeting, looked me right in the eyes and assured me that his job in these

hearings was to be completely impartial and that he was doing exactly that. Imagine my surprise when, a day later, watching the recording of the hearing that took place earlier the previous day, there was Mick Thomas rolling his eyes when an anti-spacing person was talking.
