Pursuant to IDAPA 04.11.01.550, the Oil and Gas Division Administrator (“Administrator”) of the Idaho Department of Lands hereby: (1) grants the Motion to Continue Evidentiary Hearing filed July 11, 2023, by the objector group of uncommitted owners; (2) vacates the previously scheduled August 22, 2023 evidentiary hearing; and (3) after confirming the availability of all parties, reschedules the evidentiary hearing for the above-captioned matter as set forth below.

Pursuant to Idaho Code §§ 47-328, 47-320 and 67-5242, the evidentiary hearing shall be held on Monday, September 11, 2023, at 1:00 p.m. (MST) at Payette County Courthouse, 1130 3rd Ave N, Payette, Idaho 83661. If additional time is necessary, the hearing will continue on Wednesday, September 13, 2023, at the same time and location.

1. All persons attending a hearing must conduct themselves in a respectful manner. IDAPA 04.11.01.553.
2. Pursuant to Idaho Code § 67-5242(3)(c), all other interested persons will have the opportunity to present public testimony at a separate evening session of the hearing on Monday, September 11, 2023, at 6:00 p.m. (MST). That session will also take place at Payette County Courthouse, 1130 3rd Ave N, Payette, Idaho 83661. Any person planning to testify during this time will be treated as a public witness, with rights and status in this

matter as defined by IDAPA 04.11.01.355. The hearing officer may set time limits for public testimony.

On or before Wednesday, August 23, 2023, by 5:00 p.m. (MST) all witness lists, exhibit lists, and electronic copies of all exhibits shall be electronically filed with the Administrator and copies shall be electronically served on the attorneys for those parties that attended the May 2, 2023 prehearing conference. IDAPA 04.11.01.606. Each party must label each exhibit with a prefix of the party's name or identifying group. Witness lists must indicate whether the witness will testify by videoconference, teleconference, or in person. The Administrator will post those documents on the hearing website prior to the hearing.
5. Parties are strongly encouraged to stipulate to the admission of exhibits in advance of the hearing. Stipulations may be entered orally on the record at the hearing.


