AND SETS ORDER FOR HEARING.**

Pursuant to IDAPA 04.11.01.565, the hearing officer acknowledges receipt of pre-hearing motion.

Pursuant to IDAPA 04.11.01.558, the hearing officer proposes order of presentation at hearing.

1. Hearing. The scheduled hearing in this matter is set for March 9, 2021 @ 1pm (Mountain Time), and if necessary, shall continue on March 10, 2021 @ 9:00am.

2. Pre-Hearing Motion. On February 25, 2021, counsel for Snake River Oil and Gas, LLC (“Snake River”) filed a *Motion by Snake River Oil and Gas, LLC for Summary Disposition of Contested Case*. Absent the hearing officer granting summary disposition, the motion alternatively requested to be treated as a pre-hearing brief.

- a. The hearing officer has reviewed the motion and before ruling, wants to give other parties a chance to respond. Per IDAPA 04.11.01.565, parties answering or responding to the motion have 14 days to respond. Accordingly, parties have until 5:00 pm (Mountain Time) on March 11, 2021 to file a written response. Parties may also respond via oral argument during the March 9th & 10th hearing.

3. Order of Presentation at Hearing. IDAPA 04.11.01.558. The hearing officer is flexible as to the order in which parties present their arguments and testimony at hearing. The following order is suggested by the hearing officer so parties are prepared and to promote an efficient and orderly proceeding. Witnesses will be available for questions and cross-examination immediately following their testimony. Suggested order of the proceeding:

- a. Opening remarks by hearing officer.
- b. Optional opening statements by interested parties.
- c. Citizens Allied presents arguments and testimony
- d. Snake River presents arguments and testimony
- e. Department of Lands presents arguments and testimony
- f. Oil & Gas Conservation Commission presents arguments and testimony
- g. Presentation from any other hearing participant(s) or interested party(ies)
- h. Optional closing arguments
- i. Concluding remarks by hearing officer
