**PREHEARING ORDER &  
NOTICE OF HEARING**

---

On July 1, 2020, pursuant to the May 14, 2020 *Notice of Prehearing Conference; Order Setting Deadline for Objection, Response, and Prehearing Motions*, (“*Notice of Prehearing Conference*”) a telephonic prehearing conference was held in the above-captioned matter, as provided for in IDAPA 04.11.01.510. All parties who participated in the Conference attended via telephone and Mick Thomas, the Oil and Gas Division Administrator of the Idaho Department of Lands (“Administrator”) conducted the proceedings as the presiding officer while Deputy Attorney General Kristina Fugate, attended on behalf of the Administrator.

**PREHEARING ORDER**

Pursuant to IDAPA 04.11.01.513, the hearing officer enters this Prehearing Order:

1. The *Notice of Prehearing Conference* provided: “Participation in the prehearing conference is mandatory for the Applicant and uncommitted mineral interest owners who would like to participate in the evidentiary hearing as parties.”
2. The following individuals participated in the Prehearing Conference: Michael Christian, attorney for Applicant; James Piotrowski, attorney for Judith and Jimmie Hicks, Karen Oltman, Donald and Phyllis Gruell, Shady River, LLC, Carrie Grant, Shannon Benedict, Sharon Simmons, Lowell and Geraldine Davis, Sharon Simmons, James and Beverly Smith, Dana

Harris, Sandra Dunlap, and Citizens Allied for Integrity and Accountability; David Eastman, employee for Woodgrain Millwork, Inc. (“Woodgrain”), representing Woodgrain and Kelly Dame; Stephanie Bonnie, attorney for City of Fruitland; Deputy Attorney General Joy Vega, attorney for the Idaho Department of Lands; and James Thum, Oil and Gas Program Manager for the Idaho Department of Lands.

3. The hearing officer proposed an August 13, 2020 hearing date with possible options to hold the hearing via videoconferencing, by telephone, or in-person. All participating parties agreed that conducting an evidentiary hearing via Zoom videoconferencing would be acceptable to ensure compliance with COVID-19 safety requirements. All participating parties also indicated they had the technology to participate in the hearing via Zoom. The hearing officer also proposed holding an evening public witness portion of the hearing via Zoom with an option to submit public witness testimony in-person in Fruitland. No parties objected to holding the public witness testimony in this format.
4. The evidentiary hearing shall be held on August 13, 2020, via Zoom. The hearing will start at 9:00 am (MT). If additional time is necessary, the evidentiary hearing will continue at the same time on Friday, August 14, 2020. Interested persons will have the opportunity to present public testimony as public witnesses at a separate evening session of the hearing on August 13, 2020 at 6:00 pm (MT), pursuant to Idaho Code § 67-5242(3)(c) and IDAPA 04.11.01.355. The Administrator may set time limits for public testimony. Public witness testimony will be held via Zoom videoconference with an in-person testimony option available in Fruitland for those persons who may not have the technology to use Zoom. Please see the Notice of Hearing, below, for additional attendance details.

5. Witness lists, prepared testimony, exhibit lists, and electronic copies of all exhibits shall be electronically filed with the Administrator and copies shall be electronically served on the parties attending the prehearing conference on or before August 10, 2020 at 9:00 am (MT). The Administrator will post those documents on the hearing website prior to the hearing.
6. Parties are strongly encouraged to stipulate to the admission of exhibits in advance of the hearing. Parties are encouraged to indicate to the Administrator which exhibits have been stipulated to by August 10, 2020. Stipulations may also be entered orally on the record at the hearing.
7. Exhibit labels / numbers: Snake River shall identify exhibits with “SR” followed by consecutive numbers (e.g., 1, 2, 3); Objectors represented by Mr. Piotrowski shall identify exhibits with “P” followed by consecutive numbers; The City of Fruitland shall identify exhibits with “F” followed by consecutive numbers; and the Department shall identify exhibits with “IDL” followed by consecutive numbers.
8. No party has submitted a request for subpoena, and no subpoenas have been issued under IDAPA 04.11.01.525, or pursuant to Idaho Code § 47-329(2).
9. Documents submitted into the administrative record in this matter can be viewed online at: <https://ogcc.idaho.gov/administrative-hearings/>. The Administrator has also attached to this Prehearing Order a list of documents submitted into the record (Exhibit A).
10. Responses received in this matter have referred to the proceedings in Docket No. CC-2016-OGR-01-004 and Docket No. CC-2019-OGR-01-002. Both of those dockets proposed spacing units that included portions of the spacing unit proposed in the above-captioned matter. For that reason, at the prehearing conference the Administrator took official notice of all

documents filed in Docket No. CC-2016-OGR-01-004 and Docket No. CC-2019-OGR-01-002. *See* IDAPA 04.11.01.602.

11. During the Prehearing Conference, Ms. Vega asked whether the hearing officer would allow Mr. Thum to ask certain technical questions directly to Snake River's technical witnesses. Due to the technical nature of certain geologic evidence that might be presented at hearing, the Administrator will allow Mr. Thum to directly question technical experts in the limited instances where it is necessary given Mr. Thum's technical expertise.
12. After inquiry from the Administrator to Mr. Piotrowski about the location of his uncommitted mineral interest owner clients and whether those outside the proposed unit intended to intervene as parties, Mr. Piotrowski indicated that those mineral interest owners that were outside of the proposed spacing unit were granted intervention in AM Idaho's similar application in Docket No. CC-2019-OGR-01-002, but he would review the record and may file an intervention on their behalf in this matter.
13. Mr. Christian noted that he did not believe Woodgrain was a mineral interest owner in the proposed unit area and asked for clarification. The Administrator asked Mr. Eastman for a response, but Mr. Eastman was no longer on the phone and had already left the call at an undetermined time during the prehearing conference.
14. The Administrator contacted Mr. Eastman directly after the prehearing conference by phone to ask whether Woodgrain and Kelly Dame were uncommitted mineral interest owners within the proposed unit. The Administrator followed up by e-mail, and that e-mail conversation is attached to this order as Exhibit B to ensure all parties have this written communication. *See* IDAPA 04.11.01.417. Woodgrain and Kelly Dame are not uncommitted mineral interest owners within the proposed unit and are therefore not parties at this time.

15. Any late motions to intervene must be filed in accordance with IDAPA 04.11.01.350-354. Motions to intervene not timely filed must state a substantial reason for delay. IDAPA 04.11.01.352.
16. The Administrator noted Mr. Piotrowski's June 12, 2020 *Motion of Errata, or Motion to Substitute and/or Amend* ("*Motion to Substitute*"), which requested to substitute his June 12, 2020 *Objection* for the document he inadvertently filed June 11, 2020. No responses or objections were received to the *Motion to Substitute*. The Administrator granted the *Motion to Substitute* during the prehearing conference.

### NOTICE OF HEARING

NOTICE IS HERBY GIVEN that on Thursday, **August 13, 2020** at **9:00am (MT)** the Administrator Mick Thomas will hold an evidentiary hearing on Snake River Oil & Gas, LLC's ("Snake River's") application for spacing order establishing a 300-acre spacing unit consisting of the E ½ of the SE ¼ of Section 9, SW ¼ of Section 10, the N ½ of the N ½ of the NW ¼ of Section 15, and the N ½ of the NE ¼ of the NE ¼ of Section 16, Township 8 North, Range 5 West, Boise Meridian, Payette County, Idaho. If additional time is necessary, the evidentiary hearing will continue on Friday, **August 14, 2020** at **9:00 am (MT)**. The hearing will be held via Zoom videoconference. Idaho Department of Lands will e-mail a participation link to those parties who indicated their participation at the prehearing conference. The hearing will be broadcast live via Facebook Live. The link will be posted on the IDL website prior to the hearing.

Pursuant to Idaho Code § 67-5242(3)(c), interested persons will have the opportunity to present public testimony as public witnesses at a separate evening session of the hearing on **August 13, 2020** at **6:00 pm (MT)**. Those interested persons will have the rights and status in this matter as defined by IDAPA 04.11.01.355. The Administrator may set time limits for public testimony.

Public witness testimony will be held via Zoom videoconference with an in-person option for Zoom testimony also available for those persons who may not have Zoom technology at home. The in-person option will take place at the Fruitland City Hall, 200 S Whitley Dr, Fruitland, ID 83619. The number of participants present at the City of Fruitland City Hall will be limited to comply with any COVID-19 physical distancing and safety requirements, including the wearing of masks if mandated. Those who intend to participate as public witnesses via Zoom or in-person should contact Kourtney Romine at [kromine@idl.idaho.gov](mailto:kromine@idl.idaho.gov) by **5:00 pm (MT) on Wednesday, August 12, 2020** to RSVP for the in-person option or obtain the login information for Zoom participation. Please note that comments via Zoom and in-person comments will be given the same weight and consideration regardless of the method used to testify.

The purpose of this evidentiary hearing is to receive evidence and testimony regarding Snake River's application for a spacing order establishing the above-captioned 300-acre spacing unit. The existing Fallon #1-10 well is located in that proposed unit. The Administrator is authorized to conduct this hearing pursuant to Idaho Code §§ 47-318 and 47-328. At this spacing evidentiary hearing, the Administrator will not consider evidence related to integration or "just and reasonable" terms and conditions of an integration order provided in Idaho Code § 47-320.

The Administrator will issue a written decision within 30 days of the hearing. Idaho Code § 47-328(3)(e).

This proceeding is governed by the Oil and Gas Conservation Act (Chapter 3, title 47, Idaho Code); the Idaho Administrative Procedure Act (Chapter 52, title 67, Idaho Code); Idaho Rules of Administrative Procedure of the Attorney General (IDAPA 04.11.01), to the extent that the Rules of Administrative Procedure are not superseded by Oil and Gas Conservation Act; and the Rules Governing Conservation of Oil and Natural Gas in the State of Idaho (IDAPA 20.07.02).

A copy of the Rules of Administrative Procedure are available at the Idaho Department of Lands office located at 300 N. 6th Street, Suite 103, Boise, Idaho, and at the Office of Administrative Rules Coordinator's website, <http://adminrules.idaho.gov>.

The hearing location meets the accessibility requirements of the Americans with Disabilities Act ("ADA"), in accordance with IDAPA 04.11.01.551. If a person requires assistance of the kind the agency is required to provide under the ADA in order to participate in or understand the hearing, the agency will supply the assistance upon request. 
