MOTION OF APPLICANT FOR ORDER DETERMINING CAIA IS NOT A PARTY

Citizens Allied for Integrity and Accountability ("CAIA"), describing itself as a "a nonprofit, membership-based association," joined in an Objection to Spacing Application ("Objection") filed in this matter on March 23, 2024.¹

Idaho Code § 47-328(3)(b) provides that in an application for an order establishing a spacing unit, "[o]nly an uncommitted owner in the affected unit may file an objection or other response to the application, and the uncommitted owner shall file at least fourteen (14) days before the hearing date provided in the notice." CAIA is not an uncommitted owner in the affected unit, and thus has no statutory right to file an objection or participate in this proceeding as a protestant party. See IDAPA 04.11.01.155 ("protestants" in a contested case are: "Persons who oppose an application . . . and who have a statutory right to contest the right, license, award or authority sought by an applicant[.]")

CAIA has repeatedly attempted to insert itself as a protestant party in previous proceedings controlled by Idaho Code § 47-328(3)(b). Prior to cases being heard by OAH, the Administrator

of the Idaho Department of Land's Oil and Gas Program applied the restriction in Idaho Code §47-328(3)(b) to determine that CAIA was not a party. *See* the Administrator's August 12, 2021 "Order Determining that CAIA is Not a Party and Denying Petition to Intervene," entered in Docket No. CC-2021-OGR-01-001 (available at <u>https://ogcc.idaho.gov/wpcontent/uploads/024_20210812_OrderDeterminingCAIAisnotaParty-</u> DenyingPetitionIntervene.pdf), the Administrator's September 15, 2021 "Order Determining CAIA is Not a Party and Denying Petition to Intervene," entered in Docket No. CC-2021-OGR-01-002 (available at <u>https://ogcc.idaho.gov/wp-</u>

<u>DenyingPetitiontoIntervene.pdf</u>), and the Administrator's "Order Determining CAIA is Not a Party," entered in Docket No. CC-2023-OGR-01-001 (available at <u>https://ogcc.idaho.gov/wp-</u> <u>content/uploads/027_20230322_OrderDeterminingCAIAisnotaParty.pdf</u>)

CAIA may still be able to participate in the evidentiary hearing of this matter as a public witness, with the rights set forth in in IDAPA 04.11.01.355.

For the reasons set forth above and those set forth in the Administrator's previous orders, in particular because of the limitation set forth in Idaho Code §47-328(3)(b) and IDAPA 04.11.01.155, Applicant respectfully requests an order determining that CAIA is not a party to this proceeding.
