- 2. Pending Rule IDAPA 20.07.02, Conservation of Crude Oil and Natural Gas Presented by Eric Wilson, Program Manager-Minerals

*DEPARTMENT RECOMMENDATION:* Direct the Department to submit the Pending Rule for IDAPA 20.07.02, "Rules Governing Oil and Gas Conservation in the State of Idaho" to the 2012 legislative session.

For the record, Governor Little recused himself from voting on this item due to a potential conflict of interest; Governor Little's family ranching operation is currently in negotiations on a gas lease. The Secretary of State was duly notified of this potential conflict of interest.
