Final Minutes Idaho Oil and Gas Conservation Commission Regular Meeting October 11, 2017

The regular meeting of the Idaho Oil and Gas Conservation Commission was held on Wednesday, October 11, 2017 in the State Capitol, Lincoln Auditorium (WW02), Lower Level, West Wing, 700 W Jefferson St., Boise, Idaho. The meeting began at 1:02 p.m. Chairman Dickey presided. The following members were present:

For the record, all five Commission members were present with Commissioner Breedlovestrout joining via teleconference at 1:06 p.m.

1. Division Administrator's Report

Secretary Thomas announced that there is no November Commission meeting. The previously scheduled November and December meetings were combined and will be held on Thursday, December 7, 2017.

A. Financial Update

DISCUSSION: Commissioner Classen asked what the funding was for Ground Water Protection, Secretary Thomas responded that \$20,000 for the Ground Water Protection Council was for the Risk Based Data Management System and Data Miner which will be discussed later in the meeting. Chairman Dickey asked what OE stood for which had a charge of \$4,000, Secretary Thomas clarified that was for Operating Expenses and that the \$4,000 was for travel related charges.

B. Summary of Current Well Permits

DISCUSSION: Commissioner Schultz asked when the four pending applications for permit to drill will be approved, Secretary Thomas responded that the comment period for those applications have ended and that staff will be evaluating the applications this week. Secretary Thomas also noted that the current integration application was withdrawn. Commissioner Breedlovestrout asked how deep the Federal #20-3 well was expected to be, Secretary Thomas

responded that it will be approximately 7,000 feet and that the surface casing went down to 2,047 feet. Commissioner Classen asked if the well was going to be vertical or lateral, Program Manager James Thum responded that it would be slightly deviated. Commissioner Classen asked about further knowledge of the target, Mr. Thum responded that the operator did report a proposed target but that it was redacted on the posted application [per 2016 statute – Idaho Code § 74-107 and 108]. Mr. Thum clarified that the Department is aware of the intended target.

2. Approval of Minutes – September 21, 2017 Regular Meeting (Boise)

CONSENT AGENDA COMMISSION ACTION: A motion was made by Commissioner Schultz that the Commission approve the meeting minutes on the Consent Agenda. Vice Chairman Shigeta seconded the motion. The motion carried on a vote of 5-0.

DISCUSSION: Commissioner Classen stated that the Guidelines were discussed at the last meeting and that they were well written.

COMMISSION ACTION: A motion was made by Commissioner Classen to accept the Idaho Oil and Gas Conservation Commission Guidelines. Vice Chairman Shigeta seconded the motion. The motion carried on a vote of 5-0.

Commissioner Schultz referred back to the Commission Guidelines and stated that the meeting dates, times, and locations were subject to change at the discretion of the Commission Chairman.
