Move out the slickline unit and move in well flow testing equipment. Flow test the well for three (3) days. Flare the natural gas and collect the condensate and water in portable tanks. Move out all well testing equipment and properly dispose of the produced water. Sell or dispose of the produced condensate. Leave the well shut in with gauges in the well. Move in a slickline wireline unit with a crane and retrieve the electronic memory pressure gauges from the well after the test has been completed. Move out the slickline unit.
