On April 27, 2018, pursuant to the April 12, 2018 Notice of Informal Prehearing Conference Before Hearing Officer, an informal prehearing conference was held in this matter as provided for in IDAPA 04.11.01.510. All individuals who participated in the Conference attended via telephone and hearing officer Jason S. Risch conducted the proceedings as the presiding officer. The following parties participated in the Conference: Randy and Thana Kauffman, Complainants, and Michael Christian, attorney for Respondents. The following also were present: Mick Thomas, the Administrator of the Oil and Gas Division of the Idaho Department of Lands; Deputy Attorney General Kristina Fugate, on behalf of the Administrator;

Pursuant to IDAPA 04.11.01.513, the hearing officer enters this Order to create a record of the stipulations of the parties at the Conference as follows:

1. That the *Respondents* produce the information required by, and referenced in Idaho Code § 47-332(4), specifically "[C]opies of all documents, records or reports confirming the gross production, disposition and market value including gas meter readings, pipeline receipts, gas line receipts and other checks or memoranda of the amount produced and put into pipelines, tanks, or pools and gas lines or gas storage, and any other reports or records that the lessor may require to verify the gross production, disposition and market value" for both the Kauffman #1-34 and the Kauffman #1-9 wells dating back to the

inception of both wells. Information from the Kauffman #1-9 well shall include the information from both the upper and lower completions.

2. This information shall be produced to *Complainants* no later than May 30, 2018. In the event *Respondents* are unable to produce a complete response, production shall be made on a rolling basis for as much documentation as possible, with *Respondents* presenting good cause why the same could not be produced at the subsequent prehearing conference set for June 12, 2018.
