This Order shall serve as a memorialization of the Prehearing Conference held on April 17, 2019 and is entered pursuant to Idaho Rule of Administrative Procedure 153. At the outset of the hearing, Counsel for *Respondents* conveyed that they have produced what they feel is responsive to the *Complainants*' documentation requests and *Complainants* agreed that certain documentation has been produced. However, *Complainants* state they are in need of certain "trucking tickets" and "end purchaser" documentation that has not been produced. Through detailed discussion, *Respondents* appeared to take the position that they have 1) produced the trucking tickets and 2) disagree as to the characterization of what *Complainants* are calling "end purchaser" documentation and further contend that the documents requested are not in the possession, custody or control of *Respondents*.

Based on the discussion and argument the Hearing Officer Ordered:

- 1. That the *Complainants* provide a written brief of their position citing the legal basis for their requests and the facts that support their position no later than close of business April 17, 2019. ¹
- 2. That no later than April 24, 2019 the *Respondents* provide a brief responding to the *Complainants*' request.
- 3. The Hearing Officer then instructed that another pre-conference hearing will be set for May 14, 2019 at 9:00 a.m. MST, further details of which will be forthcoming under separate Order.

¹ This short deadline was selected at the *Complainants* request.
