The Barlow 1-14 well has recently come online, and, as such, Snake River is reporting its production.

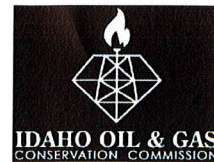


