Dear Mr. Brown:

The Idaho Department of Lands (IDL) has completed our review of this Well Treatment Permit Application submitted April 24, 2025. Enclosed is a copy of the approved permit. This permit was approved with the following stipulations:

- 1. The permittee will perform a Mechanical Integrity Test (MIT) on all casing strings prior to and at the completion of the injection procedure.
- 2. Page 2, part 1.f states the estimated injection pressures to be 1400 to 1600 psi with a maximum of 2000 psi. Based on Bottom Hole Pressure (BHP) data taken March 7, 2015 the pressure at 4064' MD is stated to be 1690.49 psi or 0.047 psi/ft. The Maximum Allowable Injection Pressure (MAIP) for this pressure treatment must not exceed 1520 psi, or 90% of the measured BHP. A copy of the 2015 BHP is attached to this permit.
- 3. The permittee shall satisfy the requests for information regarding standard operating procedures (SOPs) for sampling as stated in the comments submitted May 5, 2025 by Idaho Department of Environmental Quality (IDEQ). A copy is attached to this permit and can be found on the OGCC web page here: https://ogcc.idaho.gov/wp-content/uploads/2025.05.05_IDEQcomments_email_PTS.pdf
- 4. All well information and reports on the treatment required by Idaho Code § 47-324(5), IDAPA 20.07.02.210.06 and 210.07.d will be submitted to IDL within 30 days of the treatment being completed.
- 5. Idaho Department of Lands inspectors shall have 24-hour, unencumbered access for compliance and regulatory purposes.

Please ensure that all operations are conducted in accordance with the requirements of IDAPA 20.07.02 Rules Governing Conservation of Oil and Natural Gas in the State of Idaho.
