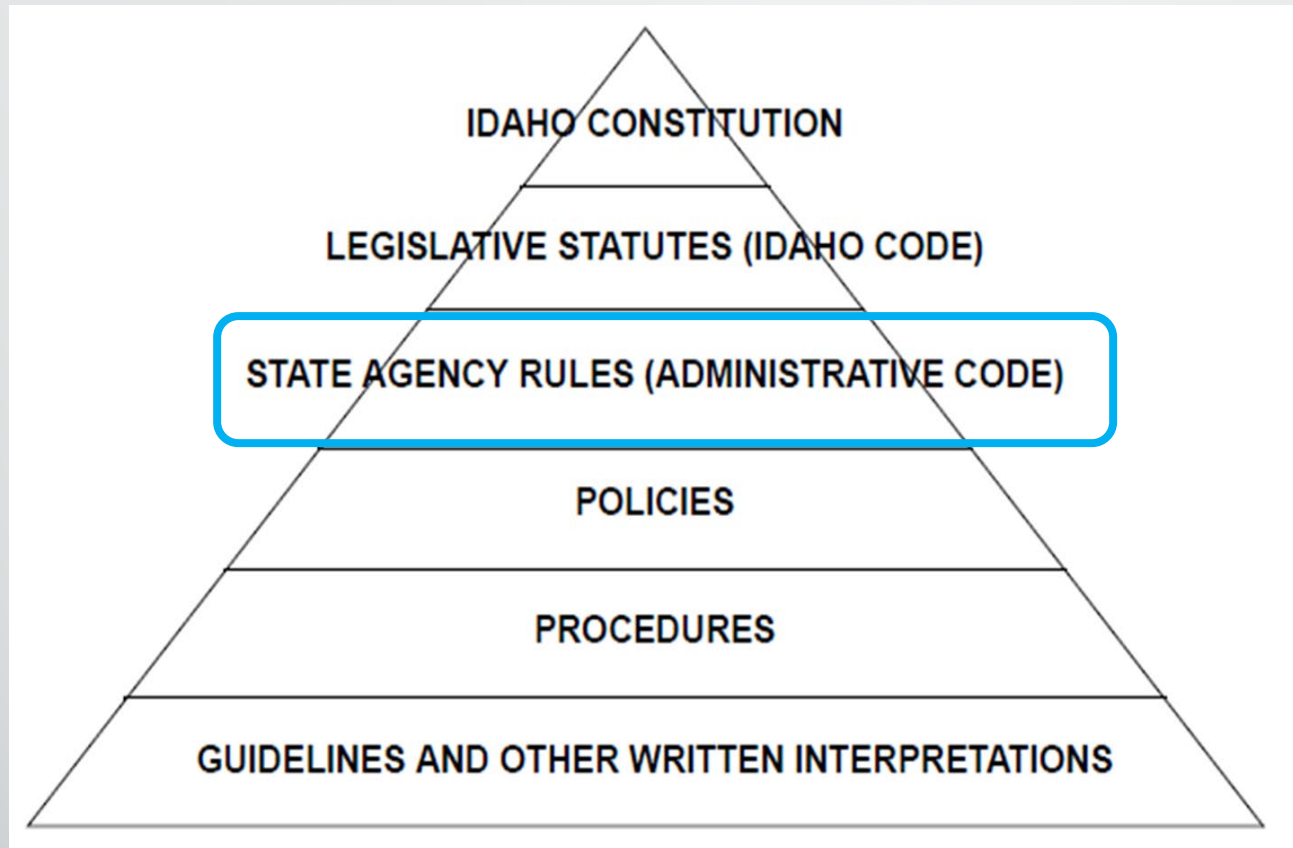

- Rule authority is rooted in statute (legislative branch) and must stay within statutory authority
- Oil and Gas Conservation is governed by Title 47, Chapter 3, Idaho Code
- IDAPA 20.07.02 must stay within the bounds of this statute

Zero-Based Regulation

- Red Tape Reduction
- Ensure Idaho regulations remain streamlined, user-friendly, and easy to understand.

Rule Text	Word Count	Restrictive Words	must	may not	shall	prohibited	required
Current Rule Text	21,533	468	146	6	255	3	58
IDL Draft #1	20,063	414	167	8	187	3	49
Reductions	1,470	54	+21	+2	68	0	9


Changes to Draft Rule Text

- Incorporation by Reference- updated
- Definitions- deleted definitions not used or those now in statute
- Abbreviations added to text body
- “Administrator” in place of “Director” per Idaho Code § 47-3
- Timeframes adjusted to conform with Idaho Code § 47-3
- Noticing requirements updated
- Wording & term consistencies
- Set time limits for Active and Inactive well extensions

Next Steps

- April 11, 15, 29 Negotiated Rulemaking Meetings
- May 21 OGCC Regular Meeting
- May 31 Public's deadline to submit written comments to IDL
- August 7 Notice of Proposed Rule in Bulletin and start 21-day public comment period
- August (TBD) Public Hearing on Proposed Rule
- August 28 Deadline to submit written comments
- October (TBD) Present pending rule to OGCC
- December Notice of Pending Rule in Bulletin
- 2025 Present pending rule to 2025 Legislature
