The Environmental Protection Agency (EPA) is proposing to issue an Underground Injection Control (UIC) Permit authorizing Class II injection well DJS 2-14 at Willow Field in Payette County, Idaho. EPA is also proposing an Aquifer Exemption of the Willow Sands from status as an Underground Source of Drinking Water.

PUBLIC HEARING FOR PROPOSED AQUIFER EXEMPTION AND DRAFT UNDERGROUND INJECTION CONTROL CLASS II PERMIT

- 2. Project Location: Willow Gas Field, Payette County, Idaho
- 3. EPA Permit: ID-2D001-A
- 4. <u>Background</u>: The U.S. Environmental Protection Agency (EPA) regulates Class II injection wells through the Underground Injection Control (UIC) program, authorized by Part C of the Safe Drinking Water Act. UIC permits authorize injection of fluids into the subsurface if injection will not cause the endangerment of Underground Sources of Drinking Water (USDWs). SROG has applied for a Class II UIC permit. SROG has also applied to exempt the aquifer in the injection zone from status as a USDW (i.e., Aquifer Exemption Request).
- 5. Summary of Proposed Actions: The EPA proposes two actions. First, EPA proposes to issue a permit to SROG that would allow conversion of an existing natural gas extraction well into a UIC Class II injection well. This well is approximately five miles north-northeast of New Plymouth, Idaho. The proposed UIC permit authorizes the injection of fluids that are brought to the surface in connection with conventional oil or natural gas production, which may be commingled with waste waters from gas plants that are an integral part of production operations unless those waters are classified as a hazardous waste at the time of injection. If the UIC permit is issued, fluids would be injected into the Willow Sands between depths of 4,908 and 5,500 feet below ground. Injected fluids are separated from shallow drinking water aquifers by claystone confining intervals. The permit establishes requirements for well construction, operation, sampling, monitoring, testing, and reporting. EPA reserves the right to terminate, modify, or revoke and reissue this permit if the authorized injection fails to protect USDWs.
 - Second, EPA proposes to approve the request by SROG for an Aquifer Exemption of the USDW contained within the injection zone associated with this injection well. EPA has determined that the USDW contained within the injection zone does not currently serve as a source of drinking water and cannot now and will not in the future serve as a source of drinking water.
- 6. <u>Public Comments</u>: Persons wishing to comment must do so in writing by the close of the Public Comment period on February 28, 2022 at 5:00 PM Mountain Time (MT). **Please submit all comments via email to osborne.evan@epa.gov.** <u>All comments must include:</u>
 - a. The statement "Draft Permit Public Comment" or "Draft Aquifer Exemption Public Comment" in the subject line of the email,

- b. The name, address, and telephone number of the person commenting (in the body of the email) and,
- c. A concise statement and the relevant facts forming the basis for the comment.

You may submit comments on both actions, but those comments must be submitted under separate emails. Due the COVID-19 pandemic, EPA will not be accepting hardcopy mail.

- 7. Public Hearings: EPA has scheduled a public hearing on February 18, 2022, at 10:00 AM MT. The purpose of this meeting is to collect oral comments on the actions proposed by this notice.
