In late September or early October 2016, AM Idaho LLC came knocking on our door regarding signing a 5 year lease with them for our mineral rights, mainly gas and oil. We were hesitant because we knew nothing about this process. We were informed by them that all they needed was 55% of the landowners to participate and it didn't matter if we signed or not, we would be compelled to participate. They told us they already had the required number of signatures from the landowners. We were told we would receive royalties based on the amount produced and there was a lot of oil and gas here. We signed the lease.

We have been informed since our signing of this lease how detrimental well and oil drilling can be to our way of life here in Idaho. Our beautiful home is on 10 acres next to the Snake River has abundant wildlife now but we are in the Fallon section. Our way of life all can be lost to us with no repercussions because of the drilling. I believe in progress however we need some assurances that our property and health will not be affected.

My husband and I regret signing the exploration lease. We have not received any royalties as promised and we will not renew our lease.

Please protect our personal, community, and state safety, health and property rights. Do not approve AM Idaho, LLC's spacing application and please disallow any further actions by them to obtain authorization to extract natural resources from our area.
