We have not signed an oil and gas leases and have no plans to sign one in the future. Our home is located just South of the Payette River, very close to the Fallon well.

I have heard the concerns and witnessed the stress from the preexisting drilling has already been caused in our community by Alta Mesa. There is so much at risk, most importantly protecting our water quality from contamination and health risks. Also, protecting the property values of the homes in the areas where drilling has happen or is projected to take place. The average Home Owner's Insurance policy does not cover damage or contamination caused by oil and gas wells or fracking.
