AMS intends to flow test the Kauffman 1-9 well in order to determine the viability for production. In order to achieve this, the bottom hole pressure will be obtained utilizing a slick line. Then, a temporary flare stack will be set up at the Little Willow Facility. AMS will place the well into operating status and produce the well utilizing the flow line from the well to the Little Willow facility, where any received natural gas will be flared. The test will be conducted for a projected 60 days in order to determine the viability of the well. Any oil (if received) will be trucked off the location and any water received will be trucked to an approved disposal site. All volumes of product received will be monitored continuously throughout the flow testing process.
