Jason:

Per paragraph 4 of your March 11, 2019 Prehearing Order, my client requests that the prehearing conference be reset from today to a reasonable later date, as it is continuing in good faith to collect documents for production to the Kauffmans.

In particular, AMI has been engaging with a third-party consultant in a re-calculation of the allocation of liquids and gas to producing wells, in order to correct an error in the allocation software that was recently discovered and has

been the subject of discussion with the Department and before the Commission. It appears likely that the re-allocation will be to the benefit of the Kauffmans, and will result in corrected production reporting being filed in the near future. AMI had anticipated that the process would be completed by now, but expects to receive a final product from the consultant within the next day to a few days.

As I may have noted previously, the separation of AMI's Idaho operations from the larger now public company has produced some challenges in getting records moved to new offices, which has also resulted in delay. However, AMI is working in good faith toward producing those additional documents to the Kauffmans which they are entitled to have made available under Idaho Code 47-332(4).

I suggest we reset the conference call to sometime in mid-April, perhaps April 17 or April 18.
