**NOTICE OF ERROR**

PLEASE TAKE NOTICE that upon review of the REPORTER'S TRANSCRIPT OF PROCEEDINGS RE: ALTA MESA'S PETITION TO AMEND THE ORDERS, certified June 24, 2018, Mr. James Thum, witness for Idaho Department of Lands, identified the following transcription errors related to his testimony:


Page 87, lines 15 through 17 contains Mr. Thum's testimony which was transcribed, in part, to read: "I worked for Anadarko, Bridge Petroleum, a company which is now known as EOC." But which Mr. Thum recalls testifying to, and which should read as follows: "I worked for Anadarko, British Petroleum, and a company which is now known as EOC." (Emphasis added to corrections).

Page 91, lines 7 through 10 contains Mr. Thum's testimony which was transcribed, in part, to read: "A depletion dry reservoir will have various characteristics that are somewhat different than a water dry reservoir." But which Mr. Thum recalls testifying to, and which should read, as follows: "A depletion drive reservoir will have various characteristics that are somewhat different than a water drive reservoir." (Emphasis added to corrections).

Page 97, lines 8 through 12, was transcribed as testimony given by Mr. Mick Thomas. However, Mr. Thum recalls providing testimony in response to the Hearing Officer's question posed at lines 6 and 7 on page 97. Therefore, the testimony at lines 8 through 12 should be attributed to Mr. Thum, on behalf of the Idaho Department of Lands.


