PREHEARING ORDER

On June 29, 2018, pursuant to the *Notice of Hearing* and *Notice of Informal Prehearing Conference*, a prehearing conference was held in the above captioned matter as provided in IDAPA 04.11.01.510. All individuals who participated in the Conference attended via telephone and hearing officer Jason S. Risch conducted the proceedings as the presiding officer. The following participated in the Conference: CPC Mineral, LLC, *Applicant*, by and through its counsel, Michael Christian; Karen Porter of the U.S. Department of the Interior, Bureau of Land Management; Joy Vega, counsel for the Idaho Department of Lands, along with James Thum, Oil and Gas Program Manager. Also present were: Mick Thomas, Oil and Gas Division Administrator for the Idaho Department of Lands and his counsel of record, Kristina Fugate.

Pursuant to IDAPA 04.11.01.513, the hearing officer enters this Order to create a record of the Conference as follows:

1. The participants discussed Mr. Thum's May 30, 2018 request for additional information from CPC Mineral, specifically information related to information or interpretations incorporating the geologic findings of the existing 20-3 well. CPC Mineral noted having replied to the request with additional information. All participants thereafter stipulated to the inclusion of this additional response into the record.

2. All participants having discussed anticipated witnesses and exhibits and stipulated to a July 6, 5:00 p.m. deadline for the filing of Witness and Exhibit Lists.
3. CPC Mineral's request for a resolution of the application without a hearing was withdrawn by CPC Mineral.
4. The Department of Lands' request to allow James Thum to directly participate in the hearing examining and/or cross-examining witnesses was discussed and stipulated to by all participants.

NOW THEREFORE, IT IS HEREBY ORDERED:

1. That any participant intending to call witnesses or introduce exhibits shall file a Witness and Exhibit List no later than July 6, 2018. All witnesses identified shall include a notation of whether the witness will be appearing personally or if extenuating circumstances require remote testimony. The Exhibit List shall include complete copies of all exhibits clearly marked for ease of identification.
2. CPC Mineral's request for resolution without hearing pursuant to Idaho Code § 47-328(3)(d) is hereby withdrawn.
3. James Thum, Oil and Gas Program Manager, shall be allowed to question witnesses at the hearing as needed.


